

3. V.V. Giri National Labour Institute (VVG NLI), Noida, Uttar Pradesh may transfer the Grants-in-Aid to the Zero Balance Subsidiary (ZBS) account of Odisha. Further, the release of Grants-in-Aid to the States is subject to the following terms and conditions.
  - i. The funds released to the State can only be utilized against the approved MCCs under the specified components, now and in future.
  - ii. The State Government shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc., in accordance with the Governments norms.
  - iii. The State would require to submit a consolidated Utilisation Certificate (UC) (as per GFR 12C) on utilization of the 75% of the total released fund for releasing of succeeding instalment.

iv. The next instalment of the fund would be released on the basis of actual expenditure incurred, project outcome and utilization certificate furnished by the State Government, as per GFR.

4. The expenditure involved is to be debited from the Budget Head 2230.02.101.10.01.31- Grant-in-Aid of NCS (HQ) during the financial year 2024-25.


